Are there airline discounts I can avail of to travel to Guam?

Do I need a passport to travel to Guam?

If you're a U.S. citizen, no passport is required to travel to Guam via Honolulu, Hawaii. Guam is a U.S. territory, and domestic travel rules apply. If you choose travel via any international route such as Japan, you will need a U.S. Passport.

However, you must present a valid government-issued photo ID at the airport for security screening and boarding.

Acceptable forms of ID include:

- A valid U.S. driver's license or state ID (REAL ID-compliant)
- A U.S. passport or passport card
- A Department of Defense (DoD) ID, including IDs issued to dependents
- Any other TSA-approved identification

Non-U.S. citizens should check visa requirements and carry a valid passport and any applicable travel documents.

Are there hotel discounts for attendees?

Is there an agenda available?

What should I wear?

Business casual attire is appropriate for conference sessions (collared shirts, polos, short sleeve, pants and closed toe shoes. no slippers or tank tops please). Comfortable clothing is recommended for optional excursions or cultural tours.

What will the weather be like during the conference?

Guam in May is warm and humid, with average daytime temperatures in the mid-80s °F (around 29°C) and occasional brief rain showers. We recommend bringing lightweight, breathable clothing, sun protection (hat, sunglasses, sunscreen), and a light rain jacket or umbrella just in case.

Will transportation be provided?

Local transportation is not included for airport transfers or general travel, but taxis, ride-shares, and car rentals are available from the Guam International Airport and throughout Tumon.

However, transportation will be provided for select off-site workshops and events, including the President's Dinner at Tao Tao Tasi and the On-Water Event at Agat Marina.

Can I bring a guest?

Yes! Guest tickets for the Awards Dinner and President's Dinner can be purchased separately.

Will there be time for sightseeing?

Absolutely! Guam offers beautiful beaches, cultural sites, and local dining. Free time is built into the schedule, and optional activities will be shared with registrants in advance.
